

WHAT IS THE HUNDRED?

The Hundred is an action-packed, unmissable and family friendly 100 ball cricket competition that will put you on the edge of your seat. A day combining lights, music, entertainment, and world class sport. Everyone is welcome!

It features world-class players and massive names from around the world. Eight city-based teams are created specifically for The Hundred and will compete over five weeks every summer.

Each team has a men's and women's squad with the two competitions running alongside each other.

Eight new teams were created for The Hundred. Those teams are:

- Birmingham Phoenix (Edgbaston)
- London Spirit (Lord's)
- Manchester Originals (Emirates Old Trafford)
- Northern Superchargers (Headingley)
- Oval Invincibles (The Kia Oval)
- Southern Brave (Utilita Bowl)
- Trent Rockets (Trent Bridge)
- Welsh Fire (Sophia Gardens)

Each squad comprises 15 players with a maximum of four overseas stars, plus no more than two centrally contracted England players in the Men's Competition.

In 2023, Southern Brave won the Women's Competition while Oval Invincibles won the Men's Competition.

COMPETITION RULES

100 BALL CRICKET

- It's 100 balls per innings. Whoever scores the most runs wins.
- The fielding side change ends after 10 balls.
- Bowlers deliver either five or 10 consecutive balls. The captain decides.
- Each bowler can deliver a maximum of 20 balls per match.

TIMEOUT

- Each bowling side gets a strategic timeout of up to 90 seconds.
- The coach can walk out to the middle of the ground and discuss tactics with their player's mid-match.


POWERPLAY

- A 25-ball powerplay for each team.
- Two fielders are allowed outside of the initial 30-yard circle during the powerplay.

MATCH LENGTH

• A match of The Hundred will last two and a half hours.








